

ABSTRAK

Puskesmas Seririt III mengalami penurunan realisasi keuangan BOK dalam beberapa tahun terakhir. Penelitian ini bertujuan untuk menganalisis implementasi kebijakan Bantuan Operasional Kesehatan (BOK) di Puskesmas Seririt III ditinjau dari empat komponen *Policy Triangle* yaitu aktor, proses, konteks dan konten.

Penelitian ini menggunakan metode penelitian deskriptif kualitatif. Teknik pengumpulan data dilakukan dengan cara wawancara mendalam dan telaah dokumen. Analisis data menggunakan analisis isi dengan metoda validasi dengan menggunakan triangulasi sumber dan triangulasi metoda. Informan berjumlah 3 orang deng purposive sampling. Berdasarkan hasil penelitian menunjukkan bahwa implementasi kebijakan BOK di Puskesmas Seririt III jika dilihat dari 4 komponen *Policy Triangle* belum berjalan dengan baik. Dilihat dari komponen aktor, konteks dan konten masih ada beberapa hal yang belum sesuai sedangkan jika dilihat dari segi proses implementasi kebijakan sudah berjalan sesuai aturan.

Implementasi kebijakan Bantuan Operasional Kesehatan (BOK) dengan pendekatan *Policy Triangle* masih memerlukan perbaikan dari unsur aktor, konteks dan konten.

ABSTRACT

The Seririt III Public Health Center has experienced a decline in BOK financial realization in recent years. This study aims to analyze the implementation of Health Operational Assistance (BOK) policies at Seririt III Public Health Center (Puskesmas Seririt III) in terms of the four components of the Policy Triangle namely actor, process, context, and content.

This study used a qualitative descriptive research method. Data collection techniques were carried out by means of in-depth interviews and document review. Data analysis used content analysis with the validation method using source triangulation and method triangulation. Informants amounted to 3 people with purposive sampling. Based on the results of the study, it shows that the implementation of the BOK policy at the Seririt III Public Health Center, when viewed from the 4 components of the Policy Triangle, has not gone well. Judging from the actor, context, and content components, there are still a number of things that are not appropriate, whereas if viewed from the point of view of the policy implementation process, it has been running according to the rules.

The implementation of the Health Operational Assistance (BOK) policy using the Policy Triangle approach still requires improvement in terms of actors, context, and content.
